


Rules on letting this property

Properties can be let if they have an energy rating from A to E.

Breakdown of property's energy performance

This section shows the energy performance for features of this property. The assessment does not consider the condition of a feature and how well it is working.

Each feature is assessed as one of the following:

- · very good (most efficient)
- good
- average
- poor
- very poor (least efficient)

When the description says "assumed", it means that the feature could not be inspected and an assumption has been made based on the property's age and type.

Primary energy use

The primary energy use for this property per year is 194 kilowatt hours per square metre (kWh/m2).
